- 1. Issue an injunction invalidating the prior hand count process for failing to comply with statutory and regulatory requirements.
- 2. Issue an injunction ordering Maricopa County to accept those individuals so designated by the Maricopa County Libertarian Party as its election board members.
- 3. Issue an injunction ordering Maricopa County to require participation by individuals so designated by the Maricopa County Libertarian Party in the hand count precinct and race selection process.
- 4. Issue an injunction ordering Maricopa County to comply with A.R.S. § 16-602 (C) in all its particulars, including that the selection of precincts shall not begin until all ballots have been delivered to the central counting center and the unofficial vote total have been made public, that the precincts to be hand counted be randomly selected before the races to be counted are selected, and that the hand count shall be conducted at the central counting center.
- 5. Issue and injunction ordering Maricopa County to conduct the hand count again, as soon as practicable, and in compliance with the statutes, regulations, and the Court's orders.
  - 6. Award Petitioners' reasonable costs and expenses pursuant to A.R.S. §12-2030.
- 7. Order such other relief, including permanent or temporary injunction, restraining order, or other order against Respondents, and awarding any other relief, as this Court deems appropriate.
